HEALTH CARE PREMIUMS

City of Phoenix retiree medical premium equivalent rates have been set for the 2010-11 plan year which begins on August 1, 2010. The City continues to offer CIGNA HMO, BCBS HMO and BCBS PPO plans with the same plan design, co-pays and deductibles you know today.

The City's medical plan has been self-insured for the past five years which means that the City pays each medical and prescription drug claim from the Health Care Benefits Trust. Premium equivalent rates are established by the City and driven by the prior year's retiree medical claim and prescription drug costs incurred. The retiree medical plans will see an average premium increase of 16.4% effective August 1, 2010. 2010-11 rates are found in the table below.

For the second year, the City has created a health insurance premium holiday. This year's premium holiday takes place in April 2010 for employees and retirees. This premium holiday keeps health insurance in full force while saving health insurance premium costs for one month. If you are wondering how much you will save in April from the premium holiday, look at your March 2010 pension check advice to find your monthly deduction for health insurance. This amount will be deducted from your April pension check. With this premium holiday taken into account, the retiree medical premium increase nets out to 6.7%.

RETIREES MAY SUPPORT CITY PROGRAMS

As a former city of Phoenix employee, you may be passionate about city services that support youth, seniors, public safety, parks and outdoor activities. Now, with cost-cutting measures impacting many of the programs, you have an effective way to help out.

It's the Change for Phoenix fund, which offers retirees and Phoenix residents the opportunity to give tax-deductible donations to the city's general fund or individual department programs. The idea for the fund came from a resident during city budget hearings where spending cuts were discussed. You may contribute any amount you wish.

The fund accepts only monetary donations with a check payable to City of Phoenix - "Change for Phoenix Fund." In the check memo line, indicate where the contribution should be designated, the general fund or a specific program or department. Mail the contribution to City of Phoenix, City Treasurer, 251 W. Washington St., 9th floor, Phoenix, AZ 85003. Visit phoenix.gov/changeforphoenix for more information.

SAVON DENTAL PLAN

This is to notify all current COPRA members who are enrolled in the SAVON Dental Discount Plan that they have had an increase in their annual fee schedule. The good news is that all current plan members will be continued (grandfathered in) at the current fee schedule rates as long as their renewal fees are submitted on time. The current rate structure is \$40/year for both single and family members. The new rate structure is \$60/year for singles and \$90/year for families.

If you have decided to stay in this discount plan rather than enroll in our new insurance options from CIGNA it will be important that your renewal fees be paid in a timely manner so as not to incur the cost of the new rate schedule.

TAX REMINDER

Reminder to COPRA members: Up to \$2,500 of U.S. Government, Arizona State or Local Government Pension income is excludable from Arizona Income. This amounts to up to \$2,500 per retiree being excluded for Arizona income tax calculation, or a savings of several hundred dollars.

The state tax portion of Tax programs, for example, may not record the income exemption for City retirees (AZ Form 140, Line C20 - Exclusion for U.S. Government, Arizona State or Local Government Pensions) unless you manually enter it. This may be due to the manner the Form 1099-R is prepared (no 'Taxable Amount', Box 2a), and not a particular fault of the program.

CITY MANAGER MESSAGE REGARDING CITY OF PHOENIX BUDGET

Feb. 12, 2010

Last week, I reported that the Mayor and City Council approved a 2 % emergency food sales tax in Phoenix. As you may know, every city bordering Phoenix currently has a food tax. This revenue will allow us to restore about \$62.5 million in city services over the next 15 months. At the direction of the City Council, we developed a seven-point plan for the use of this emergency food tax to restore vital services to the community:

- Fiscal responsibility - This component of the plan increases our contingency fund by \$3 million per year over the next five years. By doing so, it will help us avoid cuts during years when there are minor downturns in the economy.
- Seniors - This part of the plan restores five senior centers and some nutrition programs.
- Public safety - Under the plan, a significant portion will be used to restore important first responder services to police and fire.
- Community enrichment - This includes funding for five large community centers, Reach 11 and parks.
- Youth – This allocation restores seven summer recreation centers and seven year-round recreation centers.
- Libraries and learning – This restores after-school programs at 21 sites and reopens three branch libraries.
- Critical infrastructure and transportation – Finally, the plan restores some transit and light rail services and a street pothole repair crew.

This week we began our 15 community budget hearings in order to hear the community’s input on the budget and the food tax and its restorations. On March 2, the Mayor and City Council will act on a final budget.

I want to thank you for your continued hard work as we resolve these budget issues and let’s continue to do what we do best - serve the residents of Phoenix.
