COPRA - A YEAR IN REVIEW

This year has proven to be a busy and accomplished year for COPRA. The board members were busy meeting and planning early each month to be able to provide members with current information and making plans for our general meetings, especially the holiday party/meeting. They were also attending their respective committee meetings such as health care and COPERS.

A list of a few items that occurred this year:

- A Pension Equalization Program (PEP) is a permanent adjustment to your pension income amount. This year's 1.3% increase was the first PEP since 2009 when it was 1.7%.
- This year also saw a 13th check in the amount of 1%. The first in 5 years.
- Health care insurance rates increased but were kept to a minimal increase of 6.1%. Actuaries originally set retiree rates at a 9.4% increase. After the City took out the value of Healthcare Reform costs the increase was reduced to 9.1%. Then approximately \$3 million was used from the \$15 million Rate Stabilization Fund that was set up when the retirees were separated from the actives due to GASB 45. This brought the 2015 rate increase down to 6.1%. Furthermore, there continues to be a \$25 monthly reduction for those primary account holder retirees who participate in the Health Risk Assessment as a part of the Wellness Program.
- The City of Phoenix Employees' Retirement System (COPERS) went through changes again this year when Gail Strohl, administrator, moved on and Scott Miller becomes our newest administrator. He comes to us with 16 years of industry experience, most recently with Chicago Teachers retirement system.
- This year brought a change to the annual holiday party/meeting. The usual venue was no longer available which gave us an opportunity to look at changing what we do. This year we had our meeting in the evening with a band (The Screamin' Javelina). What fun we had! Hope that if you weren't able to join us this year you will be able to in 2015.
- As you all know, Proposition 487 was a citizens' initiative put on the 2014 ballot by the Arizona Free Enterprise Club. Prop 487 was a terrible piece of legislation that would have been tied up in the

CITY OF PHOENIX ONLINE CHECKBOOK

In Fiscal Year (FY) 2013-14 the City initiated an online checkbook as part of an ongoing commitment to transparency. The first phase of the checkbook provides vendor payment information which can be sorted by vendor, department and month. The Finance Department compiles the information from the City's financial system and updates the checkbook monthly. Residents have the ability to review City expenditures, search for payment information and download data.

As part of the online checkbook implementation, the City set up processes to track utilization and to address any questions from residents. The online checkbook allows residents to send questions to Checkbook@phoenix.gov. To date the checkbook has generated few questions concerning specific programs and has been viewed over 5,800 times.

Recently, the Finance Department made available the checkbook data sets for the City of Phoenix Open Data initiative. The checkbook data sets are available for the public and third party developers to create reports, utilize aggregate information and conduct data analysis. Data sets are available for all of FY 2013- 14 and Year-to-Date through FY 2014-15. The checkbook open data will be updated monthly on www.phoenix.gov/opendata.

MAYOR CREATES CIVILIAN RETIREMENT SECURITY AD HOC COMMITTEE

Mayor Greg Stanton has created a committee of city, community and business leaders to evaluate all aspects of the City of Phoenix Employees' Retirement System (COPERS). Chaired by Councilwoman Thelda Williams and Councilman Daniel Valenzuela, the Civilian Retirement Security Ad Hoc Committee will look for additional ways to reform the pension system, further securing the City's financial sustainability while remaining attractive to future employees and strengthening COPERS for existing employees. In addition to the co-chairs, the Committee includes Pamela Conboy, Wells Fargo Executive Vice President, Arizona Lead Region President; Rick DeGraw, Executive Vice President/Chief Administrative Officer, Copperpoint Mutual Insurance Co.; Sue Glawe, Vice President of Community Relations, Blue Cross Blue Shield of Arizona; Pete Gorraiz, retired Phoenix Fire Department Captain, former President of the Phoenix Firefighters Association; and Suzanne Pfister, President and CEO of St. Luke's Health Initiatives. The committee plans to meet six times and has been directed to provide recommendations to the City Council by the end of January 2015.

for years. It also would have cost the city considerably more each year in pension contributions than our current system, and could potentially have not only eliminated a defined benefit pension for new employees, but also eliminated MERP for us retirees. Working closely with the Firefighters Union, AFSCME and other affected groups we were able to defeat this proposition (and its dark money supporters) by a vote of 58% voting No to 42% voting Yes. The Mayor has a newly-formed task force that is again looking at pension reform for COPERS, but that would have little to no effect on current employees, and no effect on retirees. So stay tuned.

- Membership dues increases will be implemented in 2015 (See article on page 7). There have been no dues increases for at least a decade.

Get Prepared for Super Bowl XLIX

I am excited to share information with you about Super Bowl XLIX and the activities in and around downtown Phoenix. Although the Super Bowl will be played in Glendale, downtown Phoenix will be the epicenter of Super Bowl XLIX fan-related events.

Super Bowl Central, a multi-day festival offering free, family-friendly activities, will be spread across 12 downtown blocks. Super Bowl Central is expected to draw over 1 million visitors and will feature a main concert stage, food concessions, beer and wine gardens, nightly fireworks, and live broadcasts by NBC and the NFL Network. Additionally, the NFL Experience, NFL Media Center, NFL Honors, The Tonight Show and other events will be held at the Phoenix Convention Center, Symphony Hall and Orpheum Theatre.

In addition, the NFL announced that the Pro Bowl will be held at University of Phoenix Stadium on January 25, 2015, which is the Sunday prior to Super Bowl. Together, the Super Bowl and Pro Bowl activities will draw worldwide attention to Arizona. Last year's Super Bowl was televised in nearly 200 countries and seen by more than 100 million viewers.

Downtown Phoenix will be very busy this month, with crowds in downtown estimated to as large as 200,000 per day, including Super Bowl activities and other major events. Here are some of the major dates you should know:

- Sunday, January 18 – Rock 'n' Roll Marathon
- Friday, January 23 – True DTPHX Festival
- Saturday, January 24 – NFL Experience Opens, True DTPHX Festival
- Wednesday, January 28 – Super Bowl Central Opens (see below)
- Thursday, January 29 – NFL House Opens
- Sunday, February 1 – Super Bowl Sunday, The Tonight Show (NBC), last day for NFL Experience and Super Bowl Central

We are expecting peak attendance in downtown from Wednesday, January 28 to Sunday, February 1, while Super Bowl Central is open. Near Central Ave and Washington St, many streets will be closed, but transit services will continue. If you are coming downtown for any activity, please check phoenix.gov/azsuperbowl for information on transit, parking, and other critical information. To keep up-to-date on Super Bowl activities and events, go to azsuperbowl.com.

This is an exciting time for Phoenix and Arizona to show off our best, right at the start of 2015. We hope you will join us for all of the activity in downtown Phoenix!

THE BEST ONLINE SECURITY FIX

Worrying about bank and brokerage hacks is understandable. But money can be replaced—and you have legal protections. What you should worry about is a hacker mining your more vulnerable iCloud photos, Facebook page, or email account and impersonating you. Two-factor verification, a login protocol, makes it vastly harder for hackers to steal your digital life.

1. **The Threat:** Personal stuff like your photos and email are housed in the “cloud” not on your computer.
2. **The Setup:** Select “login approval” or “two-factor verification” under settings at sites you want to protect.
3. **The Login:** The first time you visit that site on a new computer, enter a code that’s texted to your phone.
4. **The Hassle Factor:** You only need to put the code in the first time you log in to a site on a new computer.
5. **The Backup:** In case you lose your phone, you can print out backup codes, which work once.
6. **The Protection:** A hacker needs to guess your password and have physical access to your computer.

COPRA DUES CHANGE

During 2014 COPRA contributed \$10,000 to Citizens for Responsible Pensions to support the campaign opposing Proposition 487. Its passage would have had negative financial impacts on city of Phoenix active and retired employees. As a result, the COPRA treasury experienced an unanticipated expense. To make up for this expense and to ensure the treasury's future stability to cover prepaid dues through 2020, the COPRA board determined that dues need to increase beginning in 2015. The last dues increase was at least a decade ago.

The new dues structure is \$12 annually. The option to prepay dues for five years is still available for \$50, which saves the member \$10 over those five years. The board sincerely hopes this increase does not represent a serious financial burden on any of COPRA's members.
