### RETIREMENT BENEFITS ENTITLEMENT AFFIDAVIT

Don't forget that if you received a "Retirement Benefits Entitlement Affidavit" from COPERS, you will need to complete it and return by April 13, 2018 in order to prevent any delay in future benefits. If you return the affidavit by mail, IT MUST BE NOTARIZED. If you prefer to bring the affidavit to the COPERS Office, located at 200 West Washington Street, 10th Floor, Phoenix, Arizona it can notarized there at no cost to you. It is important to understand that if the completed and notarized affidavit is not received by April 13, 2018, CO-PERS may need to suspend your benefits until they can contact you to verify your information.

I am fresh off yesterday's COPRA General Meeting. Those of you who were not with us missed hearing a lot of good information as well as an opportunity to win one of several door prizes worth \$25 each. We were lucky enough to have a couple of very informative speakers. Our first speaker was Scott Miller, City of Phoenix Pension Administrator. Our second speaker was the Assistant City Manager, Milton Dohoney Jr., who presented The State of the City update. He shared that there would be no real "budget drama" this year. The City Manager's Trial Budget that has gone forward does not

As I told you last month, our efforts to join the Arizona State Retirement System (ASRS) Health Care Program will NOT be an option for calendar year 2019. In lieu of that option, we are continuing to work with the City to explore a transitional step that would involve negotiating a fully insured program for both pre-Medicare and Medicare retirees directly with United Health Care (UHC). The plan design would mirror many of the options offered through ASRS who also uses UHC as the provider. The City would administer the program. Category MERP would be available to those that choose this option as well as regular MERP. Premiums would be deducted from pension checks. We will also be looking to bundle other services such as dental and vision. Hopefully, I will have more information to share with you next month as we progress on this front. Let's all commit to recruiting more members into COPRA so that OUR organization will be able to continue to be a strong advocate for retirees!

## **CAREIVER RESOURCES**

Becoming a caregiver is an important but often challenging journey. When an unpaid family caregiver first starts helping a loved one, the caregiver doesn't always know where to begin or where to turn for guidance.

To help close the information gap, AARP Arizona has developed resource guides in print and online. These guides offer information about organizations and agencies that provide services such as in-home care, adult day care, financial planning, legal guidance, senior housing, Social Security, Medicare, medication management, support groups, respite and more. The Phoenix Metro Caregiving Resource Guide and the Yavapai County Resource Guide share information about resources in those specific areas.

## **GUIDING THE GOLDEN YEARS**

**The Paper Chase** – The Legal Documents that can help secure your future—whatever your age.

- v **Advance Health Care Directive**: Also known as a living will, this document provides instructions on what kind of medical treatment a person wants—and doesn't want—in case of illness or incapacity.
- v **Durable Financial Power of Attorney**: This document names an agent responsible for asset and financial management in case of illness or incapacity.
- v **Durable Health Care Power of Attorney**: This document names an agent responsible for all health care matters—including end-of-life decisions—in case of illness or incapacity.
- v Last Will and Testament: This document stipulates the disposition of assets after one's death.

## CHECK OUT THESE NEW MY SOCIAL SECURITY FEATURES

A new year is a good time to explain the new features in my Social Security. These features not only save you time but put you in control of your retirement future.

There are a growing number of states (and the District of Columbia) where, if you're a resident, you can request a replacement Social Security Card online. The new online version of the Application for a Replacement Social Security Card can make getting a replacement easy and stress-free. It allows people to apply for a replacement card through My Social Security without traveling to a field office or card center, as long as you're not requesting a name change or any other change to your card. Social Security is working to add this capability to every state.

Your personal my Social Security account is secure and gives you ready access to your earnings records, Social Security benefit estimates, and printable Statements. Those who already receive benefits can view their payment history, current status, and manage their benefits.

Social Security has also made replacing your annual Benefit Statement even easier. The Benefit Statement (known as the SSA-1099 or the SSA-1042S) shows the amount of benefits you received the previous year and is needed for filing taxes. Now you have the ability to download it using online services. There's no need to visit a field office. A replacement SSA-1099 or SSA-1042S is available after February 1 for the previous tax year.

If you don't have a my Social Security account, creating one is very easy and usually takes less than 15 minutes.

## DON'T TAKE THE BAIT

How to avoid getting hooked by fiendishly effective phishing scams.

You may consider yourself too savvy to fall for a phishing scam (a ploy using a legitimate-looking email to trick you into sharing sensitive personal or financial information). However such cons remain remarkably effective: in 2016, more than 19,000 people reported losing almost \$32 million in phishing scams in the United States alone.

Part of the problem is that hackers are becoming increasingly sophisticated in their attacks. For example, one such scam used what appeared to be an authentic email from an online shopping site to lure users to a fake site where they were asked to update their account information.

As phishing emails become more persuasive, consumers should take extra care when conducting business online. Be wary of any email asking for personal information—regardless of its source. Many financial firms use a secure message center when requesting sensitive data. If you receive such an inquire via an unsecured channel, there a simple safety measure: Call the company in question.

## MEDICARE THERAPY CAPS END & DRUG COSTS ADDRESSED

Medicare beneficiaries won't have to be concerned about paying for physical, speech or occupational therapy when annual costs exceed \$2,010, as a result of Congress repealing the caps on those services as part of the budget deal President Trump signed last month.

Patients who require intensive therapy while recovering from injuries or illnesses have faced caps on what Medicare would reimburse. Congress has historically passed a series of automatic exceptions for the reimbursement limits, allowing Medicare to pay for treatments deemed medically necessary.

But that was never a certainty, leaving beneficiaries who reached the \$2,010 therapy cap worried they might miss needed treatments. The repeal ends that fear.

February's budget deal also had good news for Medicare Part D beneficiaries. It closes the coverage gap for prescription drugs—the so called doughnut hole—a year early. Part D users pay more out of pocket for their medicines once the total cost of these drugs reaches a certain threshold. Beginning in 2019, they will pay 25 percent of all their prescription drug costs from the time they enter the doughnut hole until they reach the catastrophic level.

v **Living Trust**: Unlike wills, living trust are not subject to probate court and go into effect as soon as they're signed. Assets transferred into the trust can be managed by its owner or another trustee.

**Follow the Money** – Three potential sources of elder-care support.

Investments, Pensions and Retirement Assets – Taking control of someone else's accounts typically requires a durable power of attorney, which can be written to go into effect immediately or when the account owner becomes incapacitated.

Long-Term Care Insurance – Even the best plans typically have an elimination period between when care is required and when payouts actually begin, so be aware of your obligations before coverage becomes necessary.

Social Security – When an individual becomes incapable of managing her or his benefits, the Social Security Administration will assign a so-called representative payee—typically a family member or close friend—to oversee the funds. Learn more at ssa.gov/payee.
