The City of Phoenix values your dedicated service and we are pleased to continue to offer a generous retiree health care benefit program that includes, dental, vision, legal service, pet insurance, and a choice of four (4) non-Medicare medical plans. For Medicare Eligible retirees, the City will continue to offer a premium discount along with a Qualified City Contribution to those retirees enrolled in a United HealthCare/AARP Medical Supplement plan and consent to have their monthly premium deducted from their pension check. As I write this we are finally experiencing weather that doesn't make you want to run to cooler places. And more importantly, Open Enrollment is here for Healthcare and other City Benefits. You should have your City of Phoenix 2020 Benefits Guide for Retirees in hand. If you haven't received this important resource you should contact the Benefits Office at (602) 262-4777 to get this booklet filled with important information and update your contact information. This is a valuable resource that you should keep handy for the full enrollment year as it answers all your questions related to benefits provided by the City.

If you want to enroll in one of the City Health Plans or make changes to your benefit choices for 2020, I would encourage you to attend one of the Retiree Open Enroll-

ment Fairs. They will assist you in your enrollment and any changes since eChris will not be available to Retirees for enrollment this year. There will be representatives from each of the insurance plans as well as staff from the City Benefits Office to answer your questions and assist you in enrollment. As an added bonus you and your spouse will also be able to get your flu shot. See the article in this Newsletter for all the meeting locations and times. If you are already enrolled in one of the City healthcare plans and you are happy with what you have and don't want to make any changes, you don't have to do anything. However, if you wish to make changes to anything you have enrolled in, you will have to make changes during open enrollment.

There is no rate increase for the Non-Medicare medical plans through the City. The City is also offering new Wellness programs for Non-Medicare retirees in 2020. For details on these wellness programs see page 28 of your 2020 City of Phoenix Benefits Guide.

Medicare eligible Retirees will receive information on rates directly from UHC if they are currently enrolled and will not be required to do anything for enrollment if they want to continue in the same plan offering. If you want to enroll for the first time for this plan, you will receive rate information as a part of the enrollment process. If you are currently enrolled with UHC but wish to make changes, you will need to do so as part of open enrollment. I would encourage you to attend one of the City's Open Enrollment Fairs for assistance in making changes.

As a Retiree, one of the most important decisions you make is what you do for health insurance as it is an important resource that also carries a substantial cost to your limited budget. Please consider what you do carefully. Take advantage of all the information and resources available to assist you in this decision.

I will end this message, as always, with the reminder that we are always looking for new COPRA Members. Help us recruit more of your retired City friends and acquaintances as members. Membership is our Strength!



TID BIT OF INFORMATION

Expect above-normal snowfall from New York to Boston this winter and a rainy few months in the Southeast, says meteorologist Paul Pastelok. Also expect above-normal snowfall in the upper Midwest and Great Lakes...near-to-below-normal snowfall across the Northern Great Plains...near-to-above-normal snowfall in the Central Plains...and above-normal temperatures for the Southern Plains in December and February. LINDA HENDERSON (incumbent)

Susan has a B. S. in Accountancy from the W.P. Carey School of Business at Arizona State University and is a Certified Public Accountant registered in the State of Arizona

TAMMY RYAN (incumbent)

Tammy retired in 2017 after 27 years of service. She worked in a number of City departments, mainly in the areas of budget and finance analysis. She was also an elected member of the COPERS board and served as COPERS Chair for a little over one year. In July 2019 Tammy was appointed to serve as a trustee on the COPERS Board replacing Susan Perkins as the COPRA representative. STEPS TO CHANGE YOUR FEDERAL & STATE WITHHOLDING IN ECHRIS

To access the Federal and State withholding tax information in eCHRIS, the website is echris.phoenix.gov.

Enter your User ID, Password and select the **Sign In** button. To reset your password, please call the Help Desk at 602-534-4357.

To change your federal and/or state tax withholding information, select the **Payroll** tile.

On the left side of the screen, select **W-4, W-4P, A-4 & A-4P Tax Info** to access your Federal and State tax information.

Identify the default tax record that first appears on your Tax Info page. Each Company has its own tax record and your monthly paychecks will be taxed according to its set up. For example, MERP has its own tax information and Pension (City of Phx Emp Retirement Pln) has its own tax information. It is important to make sure you are changing your tax withholding in the proper Company, so the federal and state taxes are withheld accordingly.

If you want your federal and state withholding taxes to change for your pension paychecks. You need to switch the Company to City of Phx Emp Retirement Pln by clicking on the **Company** hyperlink.

I hope you are all enjoying the fall season. As we all prepare for the upcoming holiday season I would like to share the following information. The economy is strong and our City budget is balanced. City employees continue our legacy of working smart, spending wisely and being kind to the customer. I want to share a few opportunities we have in the upcoming months.

Free fitness classes are offered at Hance Park. People of all ages are invited to join the free fitness programs offered by FitPHX, the city's healthy community initiative, at downtown Phoenix's Hance Park. Also, available is WalkPHX Wednesdays, which is a 3.2-mile social walk/run through the downtown area that takes place on the second and fourth Wednesday of the month from 5:15-7 p.m. The loop route begins and ends in the west end of the park. Fall into Fitness is an eight-week fitness series held on Tuesdays from 6-7 p.m. at Hance Park. The series runs from

Oct. 15 to Dec. 3. You may register at Phoenix.gov/FitPHX.

Each holiday season, cities across Maricopa County experience an increase in groups and individuals who want to help those who are experiencing homelessness. The 2020 Census is coming soon. As mandated by the U.S. Constitution, America gets just one chance each decade to count its population. The U.S. Census counts every resident in the United States and takes place every 10 years. The data collected determine the number of seats each state has in the U.S. House of Representatives and is also used to distribute billions in federal funds to local communities. In Phoenix, an accurate 2020 Census count represents \$533/per person totaling an approximate amount of \$866 million/a year. This funding helps to provide vital resources, programs and services such as housing, transportation, education and public safety.

After you click on the Company hyperlink, a new screen will appear. Click on the **City of Phx Emp Retirement Pln** hyperlink to change the company.

The **City of Phx Emp Retirement Plan** company will be displayed. Use the scroll bar on the right-hand side of the screen to navigate the page.

The W-4P Tax Data section is where you update your taxes for Federal withholding.

The A-4P Arizona State Tax Data section is where you update your taxes for State withholding.

Once you've entered your information, click on the **Submit** button.

Enter your login password for eCHRIS then hit **Continue**. This is your electronic signature and it saves your selection.

The next screen states that you have submitted your information successfully. Next, click the Ok button. Once the Ok button has been selected, it will bring you back to your tax information page. Depending on the timing of your changes, it may require more than one paycheck for the changes to take effect. It is recommended that you confirm your tax withholdings on your paycheck to ensure the desired tax withholdings was taken.

To sign out of eCHRIS, click on the **three horizontal lines** to access the menu. Once the menu comes up, click on **Sign Out** to exit eCHRIS.
