COPRA BOARD ELECTIONS

It is election time once again for the COPRA Board of Directors. In the October issue of the Chronicle, we asked if any members were interested in becoming a candidate for a Board position.

There are twelve elected positions on the Board, each serving a two-year term. There are four incumbent members seeking re-election, and two new candidates seeking election to the Board this year for a term covering 2022-2023. Elections are staggered with six Board positions coming up for election each year.

In addition, we need to fill three vacancies for a one-year term, as three Board members are resigning mid-term. These positions may be appointed by the Board without going through the formal election process. In accordance with the COPRA By-Laws, if there are no more than 6 candidates seeking office, a formalized ballot process is not required. Voting will be conducted by a "virtual vote" at the December COPRA Annual Meeting.

TAMMY RYAN (Incumbent)

Tammy is currently the COPRA representative on the COPERS (City of Phoenix Employee Retirement System) board. Tammy retired in 2017 after 27 years of service. She worked in a number of City departments, including City Audit, Budget & Research, Finance, Water Services, and Library, mainly in positions with financial and administrative oversight responsibility. She was also an elected member of the COPERS Board and has continued serving on that Board as the COPRA liaison. Tammy says, "I believe COPRA serves an important role as a voice for retirees, and without this unified voice we have weaker input into City policies affecting us." Tammy wishes to continue serving on the COPRA Board as she believes her experience provides valuable knowledge of City financial and retirement policies.

MARY JO SLUNDER (Incumbent)

Mary Jo is the current COPRA Chronicle Chair. She retired in 2013 after 21 years of service, entirely served at the City Clerk Department. Mary Jo worked in several capacities there, retiring as an Elections Coordinator, Assigned Citizen Support. When she retired, Mary Jo was responsible for communicating and working with City Council members and the candidates for city office, as well as all of the registered campaign finance committees. She worked with all levels of staff within the City organization. Earlier in her career with the City Clerk Department, Mary Jo was responsible for the Department's budget, payroll, and human resources. She was a member of the team that brought PeopleSoft to the City, and the migration of the City's email system. Mary Jo believes that it is important to have a strong organization representing City retirees and hopes to significantly contribute to COPRA.

Because we did not have more than 6 candidates for Board positions, a formal ballot process will not be necessary, as stipulated in the COPRA by-laws. Also, since we need to fill 9 Board positions, we will be taking nominations/volunteers from the general membership at the December general membership meeting. **Please consider serving on the Board!** This is your organization and we need your help.

OPEN ENROLLMENT FOR 2022 ENDS NOVEMBER 12!

The City of Phoenix remains committed to providing its retirees with sustainable and worthwhile health care coverage. In 2022, City retirees and their eligible dependents will have access to a variety of Medicare and non-Medicare health plans – plus dental plans, a vision plan, legal plans, and pet insurance. The City remains committed to take steps to positively impact the health of its retirees and their families by offering competitive and sustainable health plans.

As in the past, open enrollment is a passive process. If you don't want to make any changes, you don't need to do anything. If you want to make any changes, you must do so no later than 5:00 p.m. on November 12th. Please refer to your Benefits Guide, which was mailed in mid-October, for details. The guide is also available on-line at www.phoenix.gov/benefits.

13TH CHECK

COPERS recently emailed retirees some information regarding contact information and information about the 13th check. Since not all COPRA members have an email address, we want to make sure that all of our members receive this information.

"There will be no '13th check' in 2021. The '13th Check' is one of the components of the Pension Equalization Program. The Pension Equalization Program was established on October 1, 1991, when voters of the City of Phoenix approved an amendment to Chapter 24 of the City Charter, allowing pension adjustments to be paid to eligible retirees.

Just as the existence of a potential '13th check' is explained in the City Charter, so too are the criteria that must be met for payment and the rate used to determine the amount. CRITERIA: funds must be available in the Pension Equalization Reserve Fund to cover the '13th check' for all eligible retirees. RATE (minimum of 1%) the lesser of: ½ of Consumer Price Index OR Excess investment return rate OR 3% maximum

Over the decade, the number or retirees has increased by nearly 50%, about 5,000 in 2010 to over 7,500 in 2020. This rise in the number of retirees has increased the cost to provide benefits such as the '13th Check.' COPERS was able fund a '13th check' in 2014, 2015, 2016, and 2018. Other components of the program resulted in increases during the same time frame.

The Pension Equalization Reserve is funded at the end of each calendar year only when COPERS' five-year average investment performance exceeds 8%. The strong 2021 market means the chances of funding the Pension Equalization Reserve funding in early 2022 are strong. Therefore, there will be no '13th check' in 2021. The exacting criteria and rate evaluation required by the City Charter are meant to safeguard COPERS' plan assets and ultimately your pension."

Your E-mail is Your Entry

The first event since the COVID-19 pandemic began was held on Saturday, Oct. 16, at the Desert Ridge Marketplace. If you missed it, don't worry – several more are being scheduled. Community partners will be on hand to accept many items, including: hard drives, laptops, computer towers, printers, cell phones, flat screen televisions and monitors, bicycles, nonperishable food, clothing, unopened personal care products, books, office and school supplies and housewares.

Personal documents can be shredded onsite, up to five boxes for free. Additional boxes can be shredded for either a monetary or non-perishable food donation. On-site shredding will be offered until the truck is full. Any additional materials collected will be securely shredded offsite. **The event will follow health and safety protocols as people will be asked to stay in their vehicles** while masked-up volunteers do all the heavy lifting.
