CITY BUDGET SHORTFALLS BRING CHANGES TO RETIREES

We are all aware of the City budget crisis. This has caused both large and small cutbacks and reductions in service. One of these is how the Finance Department processes pension checks and advices (what you receive when you have your pension monies automatically deposited).

PENSION / MERP ADVICES:

- Currently: All pensioners who use automatic deposit receive an advice in the mail for both their pension and MERP checks.
- **Change: Starting October 2010 all pensioners will no longer receive their advices in the mail. You will be able to access that information via a computer using the e-CHRIS system. You will be receiving a letter from the City advising you of this and where you can go to learn how to use the e-CHRIS system and where you can access computers and the Internet if you do not have personal access.**
- Why: Mailing advices to pensioners costs the City \$40,000 per year.

During these very tough economic times we all have to do our share to save the City money and maximize City employment. This helps

PRESIDENT'S MESSAGE

As with previous summer breaks everyone on the COPRA Board has continued to work very hard in providing their best efforts in representing all of you on important issues with Pensions and Health and Benefits.

We have a very important meeting coming up that hopefully all of you will put on your calendars for October 7th. The new City Manager, David Cavazos, will be joining us to give an update on the "State of the City". This will be a continuation of the State-of-the City Program that we started with Frank Fairbanks several years ago and the membership has indicated an appreciation for this series to continue. I am sure that David will have a lot to share with

us about what has been going on at the City this year and what may be occurring over the next 6-12 months as well.

In addition, your participation in the COPRA Member Survey conducted this summer was greatly appreciated and we had an excellent response from many of you. Jim Flanagan and his committee did an outstanding job putting this survey together and trying to simplify the process to get more member participation, which really worked. The survey results should be appearing in next month's Chronicle along with a posting on our Website as well. The COPRA Board will continue to look at your input and focus on what improvements we can make in the organization over the next year and will share further information with you as time goes on.

Finally, you will be hearing soon from the City on a change in the processing for those of us who use the "automatic deposit" feature for our Pension and MERP checks. As we all know, the City has continued to look for ways to reduce costs wherever possible. One area that was changed last year involved the notices sent to active employees regarding the bi-weekly pay. The City stopped sending this information to them by paper with the request that they acquire any information needed on the City's computer system. This has apparently saved the City considerable costs and they now want to implement this same process for retirees. Obviously one of the most important pieces of information needed by all of us is the year-to-date information contained in the advisory sent out (taxes withheld, medical and dental payments, etc.). This is needed for income tax purposes. and the 1099 we currently receive at the end of the year does not contain some of this vital information. COPRA continues to work with the City on this issue and hopefully some solutions for our specific summary information needs will be identified, especially for those retirees who have limited or no access to computers. For those with access, we are also assisting in establishing training programs as needed to utilize the City system by those of you who would like to take advantage of that.

In closing, I hope to see many of you at the upcoming meeting on October 7th. Please try to make that important meeting.

REMEMBER YOUR BENEFICIARIES

Even in retirement our lives can be a swirl of marriages, divorces, births, deaths, in short, change. As quoted by a Greek philosopher known for his doctrine of change, "Nothing is constant but change." According to Nationwide Retirement Solutions, the administrator of the city's 457 and 401(a) Plans, problems can arise for your loved ones should you pass away without having accounted for change in your life.

The beneficiary designation(s) for your 457/401(a) Plans account with Nationwide is legally binding and takes precedence over your will or trust. That means your city of Phoenix Plans account assets will go to the person(s) you named on the beneficiary designation form on file with Nationwide, no matter what has changed since you submitted the form. If you're not sure if you have a beneficiary designation on file or if you haven't reviewed your beneficiary designation(s) since retirement, now is the time to check.

Please be sure you have a beneficiary designation on file with Nationwide and that it reflects the most current information. You should check your beneficiary designation(s) *at least once a year* and update as needed. That information is included on the quarterly account statements you receive from Nationwide, on your online account at www.phoenixdcp.com ("457" link), or you can call Nationwide at 602-266-2733 or 1-800-891-4749.

Think of your loved ones and complete a new beneficiary designation form today. Go to www.phoenixdcp.com and click on "Beneficiary Information/Forms" link or "Forms" tab on the home page to access and print the form. Or you call Nationwide at 602-266-2733 to request a form be mailed to you.

ARIZONA STATE TAX WITHHOLDING CHANGES

In June you should have received a letter from the City's Finance Department outlining changes to your Arizona State Tax withholding rates effective on your August 1 retirement pay. Through June 30, 2010, the state withholding amount was a percentage of Federal income tax withheld. For amounts withheld starting July 1, 2010, Arizona withholding is a percentage of the taxable amount of your pension payment.

The letter set forth the new rates and how to make any changes to elect a new withholding percentage that is different from the transition default rate. This can be done by completing a new A-4P or using the City's eCHRIS system. If you do not select a new rate, the transition default rate will remain in effect until you make a change.

FINANCIAL FITNESS EXPO SEPTEMBER 29

Take a positive step toward improving the “health” of your 457 / 401(a) Plans account. Attend the city of Phoenix **Financial Fitness Education Expo**, being conducted by Nationwide Retirement Solutions, the plan administrator for the City’s 457/401(a) Plans and Post Employment Health Plan (PEHP). The Expo will be on **September 29 from 9:00 a.m. to 2:00 p.m. at City Hall Atrium and Assembly Rooms A, B, C & D**. No pre-registration is required, and spouses are welcome!

Open to all city retirees and employees, the 4th annual Expo will feature:

- Two workshop topics to choose from: the basics of the city’s Plans or asset allocation and rebalancing your account to help diversify your assets in the Plan(s).
- The schedule of sessions is staggered so you can attend both workshops if you wish.
 - Retirement Fitness Fundamentals: 457/401(a) Plans and PEHP at 9:15 - 9:45 a.m. and 11:30 a.m. - 12 p.m.
 - Retirement Fitness Check-Up: Asset Allocation & Account Rebalancing at 10:45 - 11:15 a.m. and 1:00 - 1:30 p.m.
- Local plan service representatives from Nationwide to assist with your accounts in the city’s 457 and 401(a) Plans, and/or PEHP.
- Information booths include:
 - Beneficiary designations
 - Nearing retirement
 - Retiree Assistance
 - Representatives from the various fund houses will be on site to provide information and answer any questions about the mutual funds available in the city’s Plans
 - Representatives from the City’s Retirement Office (COPERS) and the Public Safety Retirement Office (PSPRS)
 - *New this year!* Representatives from the City’s Benefits Office and from the City’s medical insurance and prescription providers, CIGNA, Blue Cross/Blue Shield and Caremark.
 - Scheduling appointments with local Nationwide representatives

Also new for 2010 -- the City’s Benefits Office not only has an informational booth but will be conducting a workshop on your health insurance benefits, called “How to get the most out of your City medical plan.” The two sessions of this workshop are scheduled for 10:00 - 10:30 a.m. and from 12:15 - 12:45 p.m.

COPRA RETIREE SURVEY

A survey of retirees was developed and approved by the COPRA Board of Directors in April 2010. The purpose of the Survey was to improve COPRA. The survey was posted on www.phoenixcopra.com website and also mailed to members in the May issue of the Chronicle. The survey period was from May 1st to June 30th, 2010.

In an effort to increase the rate of response, it was announced that a \$100 Gift Card would be awarded to a member participating in the survey. A computerized random number generator was used to select the winner in July. The winner is Sandra Miller. She recently retired after working in the Police, Aviation and Parks and Recreation Departments.

There were a total of **406** responses to this survey:

181 Responded via the COPRA internet website survey
225 Responded via the May issue of the COPRA Chronicle

This is a response rate of 16%. The 2002 survey had 83 responses, which is a response rate of 10%. The increased response rate is attributed to the raffle and the ease of responding to the survey online.

The results of the survey will be discussed by the Board at the September meeting and the results will be available on the website, www.phoenixcopra.com, following that meeting. The results will also be published in the October Chronicle.
