QUESTIONS ON MEDICARE?

Copra Health & Benefit Committee representatives, in conjunction with the City of Phoenix Human Resources Department, have met with the new Benefits Assistance Program Director of the Area Agency on Aging to arrange for some informational classes on Medicare to be offered to COPRA members this Fall. We are looking at dates for the programs in mid October and November since annual enrollment this year runs October 15 through December 17. PRESIDENT'S MESSAGE



Welcome to another active season for COPRA in 2011/2012. I hope that all of you had a good summer and were able to do everything you wished to do. I say "had a good summer" since it is still 110 plus degrees in Phoenix as I write this message.

The Board continued to be busy this summer with the sub-committees on Health and Benefits along with the Retirement Board. I also continued my involvement with the Pension Reform Task Force that was charged by the Mayor to examine the Retirement System and prepare a set of recommendations for the Mayor and City Council. To remind everyone, the committee consists of ten citizen members and three members affiliated with the City. These included the chair of the Retirement Board, the head of the coalition of unions, and a retiree, which is the role I have been providing.

My message this month will focus on the Pension Reform Task Force since we have been busy during June, July and August going through "tons" of material and infor-

mation provided by the City and the consultants that were contracted to assist us in the research. One important element that came out of the meetings this summer for all City General Retirees was an understanding stated by the Chair of the Reform Committee that the recommendations, once finalized for presentation to the Council, will not focus on existing retirees but only focus on the Retirement System as it pertains to existing and future City employees. Again, however, it is important to remember that the committee is charged with making recommendations and it is up to the City Council and the voters of Phoenix in some cases to make the final determinations.

The discussions over the past several months have fallen into six areas of possible consideration. I emphasize "possible consideration" since again the committee is looking at options and these areas, and potentially others, will continue to need more dialog before the committee can begin preparing a study report to the Mayor and City Council. I would also add that there were discussions this summer as well regarding both PEP and the 13th Check and whether some changes in this area may be warranted in reference to future retirees only and not current retirees.

The six areas that have received the most discussion over the past three months include:

- 1. Discussions on the impact of adding a 5-year smoothing to the calculations
- 2. Discussions on the impact of changing the employee contribution structure
- 3. Discussions on the impact regarding possible changes in the future to the accrual multiplier (currently at 2% per year for the first 32 years)
- 4. Discussions on the impact with changing the eligibility formula (i.e. the rule of 80, etc.)
- Discussions on the impact of removing the vacation and sick leave pay from the final calculations for retirement
- 6. Discussions on the impact of eliminating certain allowances for the final calculations in determining annual earnings for retirement pay calculations(e.g. car allowance)

All six of these discussion areas have been researched by the consultants assisting the committee and only Numbers 2 and 3 provide significant savings and improvement in the financial health of the system. The remaining items are of a more minor savings if carried forward. Again, I cannot emphasize strongly enough that this is the very early stages of research and I have been duly impressed with the diligence of the committee and the kinds of questions that have been asked during the lengthy process over the past six months of meetings. Obviously some of the items if presented to Council would require a vote of Phoenix citizens and a few may also have some legal implications that would need further review.

On a special note it is also great to see some of my fellow retirees that have attended many of the committee meetings and also who have spoken up when the opportunity was provided during the public input segment of the meeting. As always, those of you who are interested in attending one of these meetings please check the public calendar on the City of Phoenix website as to time and place.

In closing, I look forward to seeing you at our October "State of the City" meeting with David Cavazos, Phoenix City Manager. These meetings are always informative and allow attendees to ask questions at the end of the planned presentation. It is always appreciated that the City Manager makes the time to join us for this important meeting and I hope you can be there as well.

CITY MANAGER'S CORNER

Hello again, friends. I hope all of you are having an enjoyable summer.

This is my first column since COPRA's summer break, and I am excited to be back in touch with all of our retirees.

We have some good news to share: The city of Phoenix finished fiscal year 2010-11 with revenues right on target, expenses under budget and a AAA credit rating, the highest credit rating of the six largest U.S. cities, and now, the federal government.

The 2011-12 budget is off to a great start, with no reductions in services to the community and no increases in taxes or fees. This represents an amazing turnaround, considering that in 2009-10 the city faced a \$277 million deficit.



Here are some other highlights from the past fiscal year:

- The city used its AAA credit rating to refinance and restructure debt, for a savings of \$44.5 million during the last fiscal year. The city's rating exceeds Houston (AA); New York City (AA); Los Angeles (AA-); Chicago (A+); and Philadelphia (BBB).
- We increased the city's contingency (rainy day) fund to \$36 million, the highest level in the city's history.
- The Innovation and Efficiency Task Force has identified \$35 million in savings since January 2010. The Task Force is comprised of city management and private-sector members from the business community.
- Phoenix continues to do more with less, with the smallest government in 40 years. Since it
 peaked in 2007-08, staffing levels in Phoenix have dropped dramatically. More than 2,500
 full-time positions have been eliminated, and the number of employees per 1,000 residents
 is now 10.4, the lowest in nearly 40 years. The budgeted salary costs for employees also
 have dropped by \$67 million over the last two years.
- The City Council voted to retain the city's property tax rate. Phoenix residents are paying lower property taxes. Since 2009-10, property taxes paid to the city have dropped by \$98 million; the average Phoenix homeowner's property tax bill has dropped from \$397 to \$235, or more than 41%.

The city is on track financially because of the leadership of the Mayor and City Council and the focus of city management, employees and the community.

Finally, I'd like to invite you to an upcoming city event – the "Never Forget Memorial Walk" that commemorates the 10th anniversary of the September 11 terrorist attacks. The walk will begin at 7:30 a.m. Sunday, Sept. 11, at Chase Bank Tower, 201 N. Central Ave., and ends at CityScape Center, Central Avenue and Jefferson Street, with a memorial ceremony beginning at approximately 8 a.m.

The Mayor, City Council, and Police and Fire Honor Guard will lead the walk, which is open to the public. I hope you can make it.
